During the 2025 Day of Caring, 62 service projects were completed with the help of approximately 900 volunteers. The United Way of DeKalb County hosts the Power of the Purse fundraiser once a year to raise money for community impact grants focused on women and children.

All board members and staff are required to read and sign a conflict of interest policy annually. If a board member has or appears to have a potential conflict of interest on an issue, said member is not allowed to participate in the vote of the potential conflicting issue.
